Agenda for reallocation meeting

Hon'ble Commission vide order dated 19.01.2024 in petition nos. 268/MP/2023 & 269/MP/2023 directed CTUIL to carry out fresh reallocation exercise for the meetings held on 20.06.23 and 03.08.23 or any subsequent reallocation meeting held for substations in Rajasthan with stipulated practice directions. Subsequently, M/s Project Nine approached the Hon'ble APTEL impugning the CERC Order dated 19.01.2024. CTUIL had also preferred it's appeals before the Hon'ble Tribunal impugning the subject CERC Order.

Now, Hon'ble APTEL vide order dated 28.05.2024 in appeal nos. 50, 51, 79, 82 & 160 of 2024, set aside the CERC Order dated 19.01.2024 on petition nos. 268/MP/2023 & 269/MP/2023. Hon'ble APTEL held that the existing practice of reallocation considering vicinity/complex approach adopted by CTUIL shall continue, if need arises for reallocation of capacity/bays, till the exercise now being undertaken by CERC to amend the regulations is taken to its logical conclusion. CERC regulation amendment in this regard are yet to be issued.

Accordingly, meeting regarding reallocation of bays/margin at following pooling stations is scheduled at 12.06.2024 at Ground Floor Conference Hall, CTUIL Office, Gurugram at 03:00 PM:

1. Bhadla Complex
 - Bhadla-II PS
 - Bhadla-III PS

2. Fatehgarh – Barmer Complex
 - Fatehgarh-III PS (Section-II)*

*In case of margin creation at Fatehgarh-IV PS, due to reallocation at Fatehgarh-III PS (section-II), same shall be offered to eligible entities of subsequent pooling stations/sections.

Agenda in this regard is enclosed herewith.

However, as per existing practice, criteria for reallocation is as under:

- i. Vacated/available bay/margin at a pooling station shall be offered to eligible entities at next/subsequent pooling stations of same complex (List of complexes in NR is enclosed at **Annexure-I**) based on the application priority & willingness for reallocation.

- ii. Under GNA regime, priority of eligible entities shall be treated as per following order for each of the pooling station:
 - a. Entities transitioned under GNA Regulations, 2022 with both connectivity & LTA as per their LTA application date & time stamp.

- b. Entities transitioned under GNA Regulations, 2022 with Stage-II Connectivity only as per their Stage-II Connectivity application date & time stamp.
 - c. Entities under GNA Regulations, 2022 as per their connectivity application date & time stamp
- iii. Due to reallocation, start date of connectivity/GNA cannot be postponed. However, **in case bay is already awarded** at present pooling station, reallocated entity shall be liable to pay the bay charges for the intervening period.
 - iv. Liability of transmission charges, if any, for any entity after reallocation shall be in accordance with CERC Sharing Regulations, 2022.
 - v. All entities are required to take prior management approval regarding their decision for opting for reallocation in the meeting. The decision taken by the applicant in the meeting shall be considered as final and based on that the reallocation shall be finalized and no changes shall be allowed afterwards.
 - vi. In case of no participation in the meeting by entity, it will be construed that the applicant is not willing for reallocation and therefore they will not be considered for the subject reallocation.
 - vii. Any vacancy/margin creation at any pooling station/section due to reallocation, same shall be offered to eligible entities of subsequent pooling stations/sections of the same complex in the same meeting.
 - viii. In case of any capacity remains vacant even after this reallocation meeting, same shall be offered to new applicants based on their application priority.
