Now, NCT vide letter dated 22.08.2025 (copy enclosed) has issued corrigendum to the cost for "Augmentation of 1x500MVA, 400/220kV ICT (3<sup>rd</sup>) at Thrissur VSC HVDC Station in Kerala." as Rs. 170Cr. instead of Rs.164Cr.

Copy of NCT letter dated 22.08.2025 is enclosed. The detailed scope of work along with implementation time frame for the above ISTS Transmission Schemes shall be as per the enclosed NCT letter and modified Minutes of the 32<sup>nd</sup> meeting of NCT dated 22.08.2025.

The implementing agency shall enter into a concession agreement with CTUIL for implementation of the aforementioned Transmission Scheme. However, pending finalization of Concession Agreement, it is requested to initiate necessary actions for implementation of the aforementioned Transmission Schemes.
