CORRIGENDUM TO OFFICE MEMORANDUM DATED 14.06.2024

Sub: Inter-State Transmission Schemes (costing up to Rs.100 Cr.) to be taken up for implementation under Regulated Tariff Mechanism (RTM)

This is with reference to Office Memorandum Ref. No. C/CTU/AI/00/18th CCTP dated 14.06.2024. In this regard, the following hereby stands modified:

i. Transmission scheme at sl.no.9:

The transmission scheme "North Eastern Region Expansion Scheme-XXIII (NERES-XXIII)" was awarded by CTUIL for implementation through RTM mode to POWERGRID with an estimated cost of Rs. 73.47 Cr. Subsequently, the cost of the subject scheme was revised to Rs. 117.65 Cr. Considering the same, it was put up for approval in 30th NCT as a fresh agenda in line with 26th NCT MoM, para 4.4.

After detailed deliberation in 30th and 31st NCT meeting, the Transmission "North Eastern Region Expansion Scheme-XXIII (NERES-XXIII)" scheme was awarded by NCT to POWERGRID under RTM mode with an estimated cost of Rs.117.65 Cr. and implementation timeframe of 30 Months from the date of allocation. Further, CTUIL vide its letter dated 04.08.2025, communicated the same to POWERGRID.

Considering the above, the transmission scheme "North Eastern Region Expansion Scheme-XXIII (NERES-XXIII)" awarded vide our Office Memorandum Ref. No. C/CTU/AI/00/18th CCTP dated 14.06.2024 shall stand superseded.

This letter shall form an integral part of Office Memorandum Ref. No.: C/CTU/AI/00/18th CCTP dated 14.06.2024 issued by CTU.
